EMERGENCY RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO PERMIT CERTAIN "TAPS" INTO THE VILLAGE OF GRAFTON'S SANITARY SEWER SYSTEM

WHEREAS, the Village of Grafton owns and operates a sanitary sewer system, including a Waste Water Treatment Plant, for treatment of raw sewage within the Village of Grafton; and

WHEREAS, the Village of Grafton services a Sanitary Sewer 208 District established by the Northeast Ohio Areawide Coordinating Agency ("NOACA"); and

WHEREAS, NOACA has the authority to define and adjust the boundary lines of Grafton's Sanitary Sewer 208 District; and

WHEREAS, in accordance with its obligations to service the above-referenced Sanitary Sewer 208 District, the Village of Grafton may be asked to service certain properties located outside the Village of Grafton's corporation limits; and

WHEREAS, the Village of Grafton may, by agreement, or by authorization from the Village Administrator and/or the designated Village Engineer, allow access by way of a permitted "Tap" into the Village of Grafton sanitary sewer system, to certain properties located outside the Village of Grafton's corporation limits, but within the Village's Right-of-Way and/or within its Sanitary Sewer 208 District; and

WHEREAS, it is in the best interest of the citizens of the Village of Grafton that certain fees and permits be required for "Taps" into the Village's sanitary sewer system by properties located outside the Village of Grafton's corporation boundaries.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF GRAFTON. STATE OF OHIO:

<u>Section 1</u>. That, any and all "Taps" into the Village of Grafton's sanitary sewer system for properties located outside the Village's corporation boundaries, shall require the following: authorization by the Village Administrator; review by the Village Engineer; a permit from the Village of Grafton; and, coordination with property owners, county officials, LORCO, ODOT, and other appropriate persons or entities as designated by the Village of Grafton.

<u>Section 2</u>. That, the required fee for each "Tap" into the Village of Grafton's sanitary sewer system for properties located outside the Village's corporation boundaries, shall be \$4,000.00.

<u>Section 3</u>. That, it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and open to the public, in compliance with all legal requirements, including the Ohio Revised Code.

<u>Section 4.</u> That, this Resolution is hereby declared to be an emergency measure, immediately necessary for the preservation of the public health, safety and welfare of the citizens of the Village of Grafton. This resolution shall be in full force and effect from and upon its adoption and approval.
