A RESOLUTION ACCEPTING THE AMOUNTS AND RATES DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE AUDITOR AND DECLARING AN EMERGENCY

WHEREAS, in accordance with the statutes of Ohio, Lorain County Budget Commission has determined the rate of taxation for the Village of Grafton for the 2019 fiscal year, and

WHEREAS, it is the determination of the Council that said rate is fair and just and should be accepted and approved by this Council, and

WHEREAS, it is in the best interest of the citizens of the Village of Grafton that the 2018 taxation rate for the Village be accepted without delay:

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL FOR THE VILLAGE OF GRAFTON, COUNTY OF LORAIN, AND STATE OF OHIO:

- Section 1. That the 2019 rate of taxation for the Village of Grafton, as set by the Auditor of Lorain County at 4.76 mills, should be and the same is hereby accepted and approved by this Council.
- Section 2. That the Clerk be and she is hereby directed to forward a certified copy of this Resolution to the Auditor of Lorain County.
- Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including the Ohio Revised Code.
- Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of Grafton, Ohio, the emergency being the immediate necessity of adopting a Resolution to provide for the public health within the Village of Grafton, Ohio.
- Section 5. That this Resolution shall be in full force and effect as soon as permitted by law after its passage and approval.
