AN ORDINANCE AMENDING ORDINANCE 09-020 AND ESTABLISHING NEW WATER
AND SEWER RATES

WHEREAS, Grafton Village Ordinance 07-009 establishes rates for water and sewer consumption and use within the Village of Grafton and Ordinance 09-020 amended rates for sewer use; and

WHEREAS, Council has determined that in order to provide adequate funds for the efficient and economical operation of the Water and Sewer Utilities, it is necessary that the water and sewer rates be adjusted at this time;

NOW, THEREFORE, BE IT ORDAINED by the Village of Grafton, County of Lorain, State of Ohio

Section 1. That, for bills rendered on or after January 1, 2019 and January 1, 2020 the rates for water consumption within the Village of Grafton shall be as follows for monthly billing periods as set forth below:

	<u>2019</u>	<u>2020</u>
For the initial 2000 gallons used the rate shall be	\$23.96/per 1000	\$25.16/per 1000
For the next 4000 gallons used the rate shall be	\$11.99/per 1000	\$12.59/per 1000
For the next 12000 gallons used the rate shall be	\$11.25/per 1000	\$11.81/per 1000
For 18000 gallons used and above the rate shall be	\$10.32/per 1000	\$10.84/per 1000

Section 2. That, the present rate for sewer use in the Village of Grafton is 55% of the monthly water bill. From and after January 1, 2019 the charge for sewer use in the Village of Grafton shall remain at 55% of the monthly charge for the consumption of water, as set forth in Section 1 of this Ordinance.

Section 3. That, sewer rate(s) for outside/other sewer district(s) shall be as determined and agreed upon by and between the Village and such districts.

Section 4. That, sewer rate for ODRC, LORCO, Lorain County and Tanglewood/Midview shall be as follows (per 1000 gal):

	<u>2019</u>	<u>2020</u>
ODRC	\$5.66	\$5.94
LORCO	\$4.84	\$5.08
Lorain County	\$6.22	\$6.53
Tanglewood/Midview	\$6.79	\$7.13

Section 5. That, any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 6. That, it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and open to the public, in compliance with all legal requirements, including the Ohio Revised Code.
