A RESOLUTION AUTHORIZING THE MAYOR OR VILLAGE ADMINISTRATOR TO MAKE APPLICATIONS FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ALLOCATION FUNDS FROM LORAIN COUNTY AND DECLARING AN EMERGENCY

WHEREAS, the State of Ohio has a program whereby local subdivisions may obtain funding for activities such as, affordable housing, anti-poverty programs and infrastructure development; and

WHEREAS, said program is commonly referred to as Community Development Block Grant (CDBG) Allocation program; and

WHEREAS, interested applicants must submit projects in the form of an application with a cost estimate, drawings and other documentation; and

WHEREAS, the Village of Grafton is an interested applicant and will submit applications to the Lorain County Board of Commissioners; and

WHEREAS, the Village of Grafton must by legislation manifest its desire to participate in the Community Development Block Grant Allocation Program and authorize funding for this program; and

WHEREAS, it is in the best interest of the Village of Grafton that it participate and be eligible to receive said funds.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF GRAFTON, STATE OF OHIO:

Section 1. That, the Mayor and/or Village Administrator, on behalf of the Village of Grafton, is hereby authorized and directed to execute and file CDBG Allocation program applications through the Lorain County Board of Commissioners which is attached hereto, marked Exhibit "A", and incorporated herein by reference and to provide all information and documentation required to become eligible for possible funding.

Section 2. That, the Village of Grafton does agree to obligate funds required to satisfactorily compete the proposed project and become eligible for reimbursement under terms of the CDBG Allocation program.

Section 3. That, it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and open to the public, in compliance with all legal requirements, including the Ohio Revised Code.

Section 4. That, this Resolution shall be in full force and effect as soon as permitted by law after its passage and approval.

Section 5. That, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of Grafton, Ohio, the emergency being the immediate necessity of adopting a Resolution to provide for the public health within the Village of Grafton, Ohio.
