A RESOLUTION REQUESTING THE OHIO DEPARTMENT OF TRANSPORTATION TO CONDUCT SPEED ZONE STUDIES ALONG STATE ROUTE 57 WITHIN THE VILLAGE OF GRAFTON TO DETERMINE REASONABLE AND APPROPRIATE SPEEDS AND TO ENSURE THAT SPEED LIMITS AND SPEED LIMIT SIGNAGE ARE IN COMPLIANCE WITH THE OHIO REVISED CODE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Grafton has the responsibility to ensure that the established speed limits along State Route 57, as well as related speed limit signage, are in compliance with the Ohio Revised Code and the Ohio Manual of Uniform Traffic Control Devices guidelines; and

WHEREAS, the Village of Grafton's Transportation for Livable Communities Initiative ("TLCI") Planning Study recognizes that speed zone studies conducted by the Ohio Department of Transportation will take into account various factors such as the number and types of vehicles on the road, roadway geometrics, roadside development, etc., to determine appropriate speed limits; and


WHEREAS, through this Resolution, the Village of Grafton requests and authorizes the Ohio Department of Transportation to proceed to undertake the appropriate speed zone studies needed along State Route 57.


NOW, THEREFORE, BE IT RESOLVED by the Village of Grafton, County of Lorain, and State of Ohio:


Section 1: That, Council for the Village of Grafton hereby requests and authorizes the Ohio Department of Transportation to undertake the appropriate speed zone studies needed along State Route 57 to determine the appropriate speed limits along such roadway within the Village of Grafton.

Section 2: That, it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and open to the public, in compliance with all legal requirements, including the Ohio Revised Code.

Section 3: That, this Resolution is hereby declared to be an emergency measure, immediately necessary for the benefit of the Village of Grafton, the preservation of the public health, and for the safety and welfare of the Village of Grafton's citizens.
