A RESOLUTION AUTHORIZING THE MAYOR AND/OR VILLAGE ADMINISTRATOR, ON BEHALF OF THE VILLAGE, TO EXECUTE AND ENTER INTO A 24 MONTH MASTER SERVICE AGREEMENT WITH VOLUNTEER ENERGY, IN ACCORD WITH THE PURPOSES AND INTENT OF ORDINANCE #03-002 RELATIVE TO THE FACILITATION AND PROMOTION OF SAVINGS ON NATURAL GAS AND NATURAL GAS SUPPLIES AND DECLARING AN EMERGENCY

WHEREAS, Council for the Village of Grafton previously passed Ordinance No. 03-002 for purposes of facilitating competitive retail natural gas service within the Village of Grafton; and

WHEREAS, the Village has determined that in accordance with the purpose and intent of Ordinance #03-002, it is in the best interest of Grafton's residents and businesses for the Village to enter into a 24-month Master Service Agreement with Volunteer Energy with a not-to-exceed price of \$3.80 per mcf, to encourage and promote natural gas savings; and

WHEREAS, Council deems it appropriate to authorize the Mayor and/or the Village Administrator to enter into and execute such Master Service Agreement on behalf of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF GRAFTON, COUNTY OF LORAIN, STATE OF OHIO:

- Section 1. That the Mayor and/or Village Administrator is hereby authorized to enter into a 24-month Master Service Agreement with Volunteer Energy with a not to exceed price of \$3.80 per mcf for the purpose of promoting savings on natural gas.
- Section 2. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and open to the public, in compliance with all legal requirements, including the Ohio Revised Code.
- Section 3. That, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of Grafton, Ohio, the emergency being the immediate necessity of adopting a Resolution to provide for the public health within the Village of Grafton, Ohio.
- Section 4. That this Resolution shall be in full force and effect as soon as permitted by law after its passage and approval.
