AN EMERGENCY RESOLUTION AUTHORIZING THE MAYOR OR VILLAGE ADMINISTRATOR OF THE VILLAGE OF GRAFTON TO ENTER INTO AN AGREEMENT WITH QUALITY CONTROL INSPECTION, INC. FOR RESIDENT PROJECT REPRESENTATION SERVICES FOR FOX RUN PHASE 6 SUBDIVISION CONSTRUCTION PROJECT

WHEREAS, it has been determined that Quality Control Inspection, Inc. shall be awarded a contract for resident project representation services for the Fox Run Phase 6 Subdivision Construction Project, and

WHEREAS, it has been determined that in order to complete the Agreement, the Council must give its approval and authorize the Mayor or Village Administrator to enter into the Agreement, and

WHEREAS, it is in the best interest of the citizens of the Village of Grafton that the project be completed, and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF GRAFTON, STATE OF OHIO:

Section 1. That the Mayor or Village Administrator, on behalf of the Village of Grafton, be permitted and directed to enter into an agreement with Quality Control Inspection, Inc., pursuant to the terms of the fee proposal that is attached hereto as "Exhibit A".

Section 2. That the amount to be expended under the Agreement is not to exceed Twenty-Eight Thousand Eight Hundred and Fifty Dollars and No Cents (\$28,850.00) as per the fee proposal.



Section 4.
