A RESOLUTION AUTHORIZING THE MAYOR OR VILLAGE ADMINISTRATOR OF THE VILLAGE OF GRAFTON TO FILE AN APPLICATION AND ENTER INTO AN AGREEMENT WITH THE SERVEOHIO, OHIO COMMISSION ON SERVICE AND VOLUNTEERISM, FOR THE PURPOSE OF OBTAINING COMMUNITY RESILIENCE GRANT FUNDING TO HELP FIGHT COVID-19 IN OUR COMMUNITY AND DECLARING AN EMERGENCY

WHEREAS, SERVEOHIO, the Ohio Commission on Service and Volunteerism provides funding for the Community Resilience Grant to support community initiatives to address significant needs in our Community as a result of the Novel Coronavirus and to allocate funds in the form of grants for these purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF GRAFTON, STATE OF OHIO:

- Section 1. That the Mayor and/or Village Administrator are hereby authorized to apply for and enter into agreement with SERVEOHIO, the Ohio Commission on Service and Volunteerism, and to administer the Community Resilience Grant and to implement the programs and expend any Village funds necessary to meet the grant program requirements, said agreement attached hereto, marked Exhibit "A", and incorporated herein by reference.
- Section 2. That the Village hereby requests that SERVEOHIO, the Ohio Commission on Service Volunteerism, consider and fund its Community Resilience program as described in the application.
- Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the reservation of the public peace, health, safety and welfare of the citizens of Grafton, Ohio, the emergency being the immediate necessity of adopting a Resolution to provide for the public health within the Village of Grafton, Ohio.
